### (a) Ron Pither and Wendy Gilson – Cuba Viva Can Organization

Mr. Pither is the owner of Varalaya Farm, an organic farm located on Mayne Island. He actively promotes sustainable farming and fair trade practices and was involved with the establishment of organic shade-grown coffee operations in Nicaragua (Ometepe coffee). He has been travelling to Cuba since the mid nineties and realizes "how Cuba significantly progresses in the sustainable provision of many human needs, including world class food, education and medical systems." He has come today to share his passion and inform Board members of an upcoming essay contest available to students as young as 16 years of age; however if the winner is between 16-19 they must be accompanied by a designated chaperone on the trip. # 8. CHIEF EXECUTIVE OFFICER'S REPORT

### (a) Partnership with ONCCEE

Ocean Networks Canada (ONC) (<a href="http://www.oceannetworks.ca/index.html">http://www.oceannetworks.ca/index.html</a>) is a not-for-profit society created by the University of Victoria to build and sustain Canada's world leadership in ocean science and technology through the NEPTUNE Canada and VENUS ocean observatories. The cabled ocean observatories support a new generation of coastal and deep ocean research and offers educational possibilities and opportunities for all students. The district entered into a partnership with Ocean Networks Canada Centre for Enterprise and Engagement (ONCCEE), a branch of ONC, which will involve educational opportunities for students:

- 1. Students will spend time at UVic with ocean scientists will begin late March 2012
- 2. Ocean scientists will visit SIMS and GISS to work with students and help them develop research projects (IDS)
- 3. Students can engage on the website for "digital fishers" <a href="http://digitalfishers.net">http://digitalfishers.net</a> where they will play a real role in research

# (b) Bill 28 Update

The changes to the *School Act* made by Bill 28, the Public Education Flexibility and Choice Act, "remain in effect until April 13, 2012 or until it is amended or replaced by constitutionally valid legislation prior to that date". The legislation removed school organization issues such as class size and

composition "from the realm of the collective agreement into the realm of legislation. Class size was no longer something that could be the subject of collective bargaining; it was now defined by law and public policy". Paul Straszak, President and CEO of PSEC, was appointed by government to coordinate the consultation process and has proposed the government and BCTF enter into good faith negotiations. BCPSEA will continue to monitor the process and keep districts informed; however government remains responsible for this process.

# (c) Strike Update

Still in question is what can be bargained locally and what is bargained provincially; however progress is being made. Local bargaining at our district level will begin again in the New Year. No report cards this term; however there have been informal conversations between parents and teachers and students and teachers. Teachers will provide all marks for transcripts for students graduating and entering post-secondary institutions.

# (d) Work by the Education Leadership Team (ELT) - Personalized Learning

The ELT has had in-depth discussions about what "personalized learning" means for our district and what the curriculum could look like. Topics for discussion included assessments, reporting, key competencies, nature-based work. The team will refine their plan for personalized learning and forward it to the Ministry. There is no date set by the Ministry regards when they will implement their plan on personalized learning.

#### (e) Minister Abbott's Visit to Windsor House

Minster of Education, George Abbott will visit Windsor House School tomorrow afternoon. He has stated he would also like to visit Salt Spring Island in the Spring.

# (a) Monthly Expenditure Report

The monthly expenditure report indicates that with 0.3333 % of the year completed, 0.2671 % of the budget has been expended. We are 6.62 % below budget at this time. A present, we are experiencing the highest level of teacher sick time since the 2004/2005 school year and it is almost double of what the district experienced at this time last year.
