3. BUSINESS ARISING

Parent Jenny McLean was present to speak briefly with Board members regarding her concern about cell phones and to share an article about an industrial plant in Malaysia that supplied special minerals to the personal electronics industry for use in all types of personal electronic devices. The plant operated some 30 years ago and produced vast quantities of toxic and radioactive waste material. (a) Kris Fullbrook

Kris Fullbrook, Stewards in Training Program Coordinator for Salt Spring Island Conservancy, spoke to the programs the conservancy offers School District #64 (Gulf Islands) students from the new Kindergarten program and Grade 8 orienteering program to all the programs and field trips offered over the years to approximately 700 students in Grades K to 8. The 'Stewards in Training' program is almost completely run by volunteers of which they have approximately 150-200 listed in their data base. - 2. to continue to partner with SD64 and local businesses

(a) Board Elections

(b) Nature Kindergarten

Shelly Johnson, Principal of Fulford Community Elementary School and Janet Hoag, Grades K to 5 Coordinator and Early Learning Coordinator presented on nature kindergartens to Board members on Committee Day November 28 and their desire to run a program in School District #64 (Gulf Islands).

It was moved and seconded that the Board of Education supports, in principle, the development of a nature kindergarten program pending the recommendations from a feasibility committee by the February 13, 2013 Board meeting.

(c) Notice of Motion for Local School Calendar

The district received recent information from the Ministry of Education regarding new legislation and regulations around local school calendars. The *School Calendar Form* is required to be submitted by each district in the province to the Ministry and must be received by them no later than March 31, 2013. The district will submit a school calendar for the 2013/2014 school year.

Vice Chair Pete Williams presented the following Notice of Motion:

It was moved that the Board of Education adopts a Local School Calendar for the 2013/2014 school year that reduces the number of instructional days by approximately 25 to 30 resulting in a four-day school week. The instructional time from these days will be added to the remaining days of instruction. The resulting savings will allow the district to preserve programs and options for our students. The motion will be tabled at the regular Public Board meeting on February 13, 2013.

(d) Pender Student

Trustee Katharine Byers reported to Board members a Grade 10 Pender Island student appreciates funding she receives to board on SSI so she can partake of activities through the week while attending GISS.

(e) Connecting Generations

Trustee Katharine Byers attended a recent CRD meeting around climate action and sustainability. She provided participants information about the district's Connecting Generations program, which was well received. Some people are already involved and others came forward to express a desire to become involved.

8. CHIEF EXECUTIVE OFFICER'S REPORT

(a) The 2012 Educational Conference Report

This conference was a combined effort of partners from BCSSA, BCASBO, BCSTA, BCPVPA, BCCPAC, First Nations Education and the Ministry of Education and held November 15 and 16 in Vancouver. Over 1200 participants attended, of which 40 were from School District #64 (Gulf Islands). Two workshops were facilitated by groups from the district: SEEC students and Principal Steve Dunsmuir presented on Saturna and the SEEC program and SIMS Vice Principal Shannon Shields presented on *Quality Teaching and Learning* using the coaching method and how it can support teachers. School District #64 was the only district to invite students to be participants at the conference.

(b) Field Trip Request #41

A curricular field trip request (#41) from GISS teachers Louise Doucet and Halim Ouhammou to take approximately 20 Grade 11 French Immersion students to Ottawa to participate in a youth forum in Encounters Canada and to Quebec City to engage in tourist activities from April 6 to 16, 2013. Superintendent Hopkins has approved this trip pending informed consent and itinerary.

(c) Learning Improvement Fund

Class, school and district reviews were completed in order to determine how to expend this money in the best possible way for students. Two temporary positions for District Literacy and Behaviour Support Teacher Leaders of 1.0 FTE each were posted; Tanya Grant and Matti Girardi are the successful candidates. The effective dates are December 10, 2012 to June 28, 2013. They may work as a team at the larger schools and will provide consultation and follow-up time at all schools. Ms. Halstead will meet with Ms. Grant and Ms. Girardi to identify strategies to support literacy and functional behaviour of all students. Literacy and behavioural support were identified this year through the class, school and district reviews. Numeracy was identified third. Funding is provided provincially every year, but districts have to apply for it each year.

Within the Learning Improvement Funds, approximately \$30,000 has been allocated to enhance hours for current Educational Assistants.

(a) Capital Project Bylaw No. 116687 for Buses

Mr. Scotvold presented Capital Project Bylaw No. 116687 regarding the 2012 School Bus Procurement (two 84 passenger buses) for School District #64 (Gulf Islands), which specifies a maximum expenditure of \$270,262.00.

It was moved and seconded that there is unanimous approval to read Capital Project Bylaw No. 116687 in one sitting.
