8. CHIEF EXECUTIVE OFFICER'S REPORT

(a) Learning in School District #64

The synopsis of Ms. Halstead's report on the class, school and district review process is:

(c) BAA Course – Psychology 12

The locally developed course for Psychology 12 has been submitted for Board Authority / Approval. This course has been reviewed and is fully compliant with the requirements of all regulatory bodies. Ms. Halstead recommends this course for Board approval.

(d) Field Trip Request #155

An extra-curricular field trip request (#155) from Windsor House School teacher Ellen Henderson to take 10 students in Grades 9 to 12 camping and kayaking in the Southern Gulf Islands from May 26 to 30, 2014. Ms. Henderson plus two level 3 certified overnight sea kayak guides will supervise on this trip. Superintendent Halstead has approved this request.

(e) Research Project Request

A request from Elizabeth Claire Gien Sneglar, Doctoral student at the University of South Africa to conduct research on "Language and Cultural Diversity, Globalization, Inclusion and the Resultant Phenomenon of First Time Literacy Acquisition in a Second Language" enlisting the aid of cosupervisors (Principals) at Fernwood, SIMS, Fulford and Phoenix Elementary Schools. 9. CORPORATE FINANCIAL OFFICER'S REPORT

(a) Monthly Expenditure Report

The monthly expenditure report, as at April 30, 2014, indicates that with 0.8333 of the year completed, 0.8314 of the budget has been expended. We are 0.19% below budget at this time. Mr. Scotvold stated there would likely be a small deficit at the end of the school year in the area of 1 to $1\frac{1}{2}$ %.

(b) Annual Budget Bylaw for 2014/2015

Manger of Finance Cindy Rodgers presented and explained in detail the Annual Budget for the fiscal year 2014/2015, year ending June 30, 2015. Ms. Rodgers commented on the following items while comparing the total operating revenue and expenses in this budget to the current year's amended budget. Highlights include:

- Increase in unique geographic funding for 2014/2015
- Projected holdback will not be included in this preliminary budget
- Anticipate that the district will not be in funding protection next year
- Increase in teachers' salaries
- Benefit cost increase
- Decrease in number of students with special needs; projected decrease in budget for Educational Assistants
- Decrease to services and supplies expenses
- Trimming water taxi costs for OIMY program
- Trimming costs for Connecting Generations program
- Decreasing costs for professional development and travel
- One time cost in 2013/2014 for supervision for school psychologist

There has been unexpected downloading of expenses from the Ministry which has caused a negative impact to the district. With this proposed budget the district is trying to avoid staff layoffs and elimination of programs.

There will be a deficit for next year and the district will use \$228,000 of a \$784,000 surplus to off set it. If this proposed budget can be adhered to, there will likely be a surplus at the end of the 2014/2015 year. Ms. Rodgers stated this is a positive picture compared to other districts in the province. She invites anyone to contact her if they have any questions or would like clarification on any points.

It was moved and seconded that there is unanimous approval to read the Annual Budget Bylaw for 2014/2015 in one sitting.

(c) Amendment to Bylaw No. 6, Board of Education Elections

The CRD incorporated mail ballot voting in their bylaws for the November 2014 elections. Costs to the district would be significant if we didn't maintain ties with CRD, hence Bylaw No. 6 is to be amended to include mail ballot voting. It also includes the change of trustee elections, which used to be held every three years to every four years beginning with the year 2014.

12. QUESTION PERIOD

Ms. Jarvey asked how OIMY will be restructured in order to cut down on water taxi costs and whether the program will run on the same two-week schedule as it has for the past year. Mr. Scotvold stated ferries will be used where possible and the district will be looking at re-organizing the program to fit into the regular school day and water taxi transportation schedules. Input regarding the program will be gathered from parents and students and reviewed for consideration for next year's program.

Deborah Nostdal, GITA President, asked what the Board's position is on cutting payments of health benefits and cancelling administration day. Chair McKenzie responded that BCPSEA held a regional meeting on May 7, 2014 and Peter Cameron, BCPSEA's lead negotiator stated at the meeting that BCPSEA is in the process of following through with both plans. Peter Cameron was appointed by BCPSEA to negotiate on behalf of Boards of Education.
