## 1. <u>SPECIAL MEETING</u>

It was moved and seconded that the Board of Education agrees to hold a Special Public meeting.

# 2. <u>SUPERINTENDENT'S REPORT ON STUDENT ACHIEVEMENT</u>

Ms. Halstead presented her report on student achievement that is to be submitted to the Ministry by January 31. She stated the goals can be commented on and indicated that the district is working towards gathering more conclusive evidence of student achievement. As a result of the labour dispute in June and September 2014, there were no Grade 9 report cards at all last year and only check lists for other grades therefore using this data as a comparator to past years is not a strong indicator of student achievement.

Ms. Halstead stated that many parents withhold their children from writing the FSAs and there were two schools last year where no students wrote. As a result, the data is skewed and the district's completion rate is 70% compared to the provincial average of 83%. Writing of FSAs is not optional but required; however many parents believe they do have the option for their children not to write. The Principal contacts each parent who indicates their child will not write FSAs. Principals will mark the FSAs on Friday, February 20.

The district has been "self-correcting" graduation completion rates each year due to the fact International students are included in the Ministry's report. This has been an ongoing conversation with the Ministry. Ms. Halstead requested Judy Smith, Principal of Special Projects to become involved with Ministry personnel regarding this long-standing issue. As a result, this year we received data corrected at the Ministry level and their data matches that of the district.

It was moved and seconded that the Board of Education accepts the Superintendent's Report on Student Achievement for 2014/2015 as presented.

### 3. <u>COMMITTEE STRUCTURES</u>

The organization and committees Board structure list was updated with several changes due to the number of new trustees on the Board as of November 2014. The revised version will be distributed to trustees and senior administration.

## 4. IN-CAMERA MINUTES OF JANUARY 14, 2015

A suggestion was made to move the In-Camera discussion of the Hearth Program to the Public minutes. As it was a preliminary discussion that involves property and staffing, Ms. Halstead recommended the minutes of this discussion remain In-Camera at this time. It was agreed to have it remain as is.
