The group feels they will be ready to submit their report to the Board in July or August; however, as the Board will not meet again until September, Mr. Scotvold has proposed he receive their proposal on behalf of the Board in order for them to proceed. Mr. Scotvold does not anticipate any foreseeable issues or problems with the project. He feels they will get good advice from the engineer.
