1. SPECIAL MEETING

It was moved and seconded that the Board of Education agrees to hold a Special Public meeting via teleconference.

2. SALTSPRING UNITED FOOTBALL CLUB / PARC's PROPOSAL

Saltspring United Football Club and PARCS presented a proposal to the district to look at the cost of installing an all weather field at the hydro field location.

It was moved and seconded that the Board supports senior management to engage in discussion with Saltspring United Football Club and PARCS to look into the feasibility and cost of an all weather field at the hydro field location as well as potential levels of financial commitment of all three parties.

Trustee Pingle questioned why all the field locations are not being considered in this proposal. Superintendent Halstead stated this was a feasibility proposal presented to the district by Saltspring United Football Club and PARCS for that particular field. This is not a proposal put forward by the district.

To include consideration of other district fields in the feasibility proposal, Trustee Pingle suggested amending the motion to remove the word "hydro".

The main motion as amended with the final wording was adopted as follows:

It was moved and seconded that the Board supports senior management to engage in discussion with Saltspring United Football Club and PARCS to look into the feasibility and cost of an all weather field at field locations as well as potential levels of financial commitment of all three parties.
