**SUMMARY**

Under direction, supports students in the development of positive social/emotional skills that facilitate academic success, while acting as a liaison between families, community partner agencies and school staff.

**DUTIES**

- Supports students in the development of positive social/emotional skills to facilitate academic success.
- Assists in developing specific strategies for students to achieve acceptable personal/social behavior patterns.
- Provides personal improvement training to students as needs are identified through collaborative planning processes.
- Develops close working relationship with students and their families.
- Participates as a member of the case management team and/or school-based team for identified students.
- Collaborates with school staff, families, community agencies and appropriate ministries as required.
- Assists with the assessment of the student's functioning and determines how it affects family, school and community. Submits verbal and written reports as required.
- Intervenes in crisis situations; collaboratively determines, develops and implements appropriate management strategies.
- Assists with the development, co-ordination and supervision of program activities.
- Provides transportation to students as needed for appointments and/or school related activities.
- Implements directives from medical professionals; assists students with the administration of medication.

Performs other assigned comparable duties within the area of knowledge and skills required by the job description. Flexible hours, as per the collective agreement may be applicable.
